



## **SOULNATURE NUTRACEUTICALS**

The term "nutraceutical" was coined from "nutrition" and "pharmaceutical" in 1989 by Stephen DeFelice, MD, founder and chairman of the Foundation for Innovation in Medicine (FIM), Cranford, NJ.<sup>1</sup> According to DeFelice, nutraceutical can be defined as, "a food (or part of a food) that provides medical or health benefits, including the prevention and/or treatment of a disease."<sup>1</sup> However, the term nutraceutical as commonly used in marketing has no regulatory definition.<sup>2</sup>

Nutraceuticals are products which have been recently discovered due to modern medicine science. They are more popular with the younger generation who are more prone to the stress of our daily lives. Nutraceuticals (often referred to as phytochemicals or functional foods) are natural, bioactive chemical compounds that have health promoting, disease preventing or medicinal properties.

Consumers are deeply concerned about how their health care is managed, administered and priced. They are frustrated with the expensive, high-tech, disease-treatment approach predominant in modern medicine. The consumer is seeking complementary or alternative beneficial products.

Nutraceuticals are found in a mosaic of products emerging from (a) the food industry, (b) the herbal and dietary supplement market, (c) the pharmaceutical industry, and (d) the newly merged pharmaceutical/agribusiness/nutrition conglomerates.

The DSHEA formally defined "dietary supplement" using several criteria. A dietary supplement<sup>3</sup>:

- is a product (other than tobacco) that is intended to supplement the diet that bears or contains one or more of the following dietary ingredients: a vitamin, a mineral, an herb or other botanical, an amino acid, a dietary substance for use by man to supplement the diet by increasing the total daily intake, or a concentrate, metabolite, constituent, extract, or combinations of these ingredients.
- is intended for ingestion in pill, capsule, tablet, or liquid form.
- is not represented for use as a conventional food or as the sole item of a meal or diet.
- is labeled as a "dietary supplement."
- includes products such as an approved new drug, certified antibiotic, or licensed biologic that was marketed as a dietary supplement or food before approval, certification, or license (unless the Secretary of Health and Human Services waives this provision).

Thus, nutraceuticals (as per the proposed definition) differ from dietary supplements in the following aspects:

- Nutraceuticals must not only supplement the diet but should also aid in the prevention and/or treatment of disease and/or disorder.
- Nutraceuticals are represented for use as a conventional food or as the sole item of meal or diet.
